No public comments on this agenda items.

Chair nominations: Comm. Davis nominates Comm. Ijadi-Maghsoodi. Comm. Benton seconds the nomination. Comm. Ijadi-Maghsoodi does not accept the nomination. Comm. Ijadi-Maghsoodi nominates Comm. Vásquez for the officer of Chair. Comm. Vásquez accepts the nomination. Comm. Vásquez is the only nominee for the office of Chair. Comm. Ijadi-Maghsoodi moves to elect Comm. Vásquez by acclamation for the office of Chair. Comm. Farjood seconds the motion. Motion passes unanimously with a 10-0 vote. Comm. Vásquez elected as Chair.

Vice Chair Nominations: Comm. Vásquez nominates Comm. Farjood and Comm. Cabrera. Comm. Farjood requests to wait to hear other nominations. There will need to be another nomination for Comm. Farjood for her to accept or withdraw the nomination. Comm. Cabrera withdrawals nomination. Comm. Cabrera nominates Comm. Gutierrez who accepts the nomination for Vice Chair. Comm. Davis nominates herself and accepts the nomination. Comm. Gutierrez nominates Comm. Custodio Suero who accepts the nomination. Comm. Nantkes nominates herself and accepts the nomination. Comm. Custodio Suero nominates Comm. Farjood who does not accept the nomination. The nominees for Vice Chair are Comm. Gutierrez, Comm. Davis, Comm. Custodio Suero and Comm. Nantkes.

Roll call votes for Vice Chair: Comm. Ijadi-Maghsoodi abstains. Comm. Cabrera votes for Comm. Gutierrez, Nantkes, and Custodio Suero. Comm. Vásquez votes for Comm. Gutierrez and Custodio Suero. Comm. Farjood votes for Comm. Nantkes, Custodio Suero and Gutierrez. Comm. Nantkes votes for Comm. Custodio Suero, Gutierrez and Nantkes. Comm. Custodio Suero votes for Comm. Custodio Suero, Gutierrez and Nantkes. Comm. Schulte votes for Comm. Gutierrez and Custodio Suero. Comm. Davis votes for Commissioners Nantkes, Gutierrez and Davis. Comm. Gutierrez votes for Comm. Nantkes, Custodio Suero and Davis. Comm. Benton votes for Comm. Guiterrez, Custodio Suero and Nantkes.

Total votes: There are 8 votes for Comm. Gutierrez, 2 votes for Comm. Davis, 8 votes for Comm. Custodio Suero and 7 votes for Comm. Nantkes. Comm. Gutierrez, Custodio Suero and Nantkes are elected as Vice Chairs.

The elections for Chair and Vice Chairs are now closed. Chair Vásquez and Vice Chairs Gutierrez, Custodio Suero and Nantkes take office effective immediately.

Approval of Minutes:

Comm. Schulte moves to approve the November 3, 2023, regular meeting minutes; Comm. Custodio Suero seconds the motion.

Custodio Suero moves to amend the main motion to reflect Comm. Custodio Suero attended the November 3, 2023, meeting. Comm. Nantkes seconds. The amendment to the main motion passes with 8 in favor, 0 against, and 2 abstentions; Comm. Farjood and Comm. Cabrera.

Comm. Custodio Suero moves to amend the main motion to reflect the November 3, 2023, meeting minutes to reflect the approval of the October 6, 2023, minutes with 7 votes; Comm. Davis seconds the motion. The amendment to the main motion passes with 8 in favor, 0 against, and 2 abstentions; Comm. Farjood and Comm. Cabrera.

The main motion as amended for the approval of the November 3,2023 meeting minutes passes with 8 in favor, 0 against, and 2 abstentions; Comm. Farjood and Comm. Cabrera.

Public Comments:

1. Kim Jones, president of the Kinship Fund, provided information regarding "The Kinship Fund." It is a new private foundation in San Diego that supports nonprofits financially and through compacity building. Those nonprofits that are working to help people pursue education and prevent the incarceration of youth and whole person health. Main reason for the introduction because is a subject matter expert in Human Trafficking. She would like to offer services because she has been working in that area for over a decade. Her previous

position was the Executive Director Center for Justice and Reconciliation at Point Loma Nazarene University where she ran various programs in human trafficking for survivors and prevention.

Business:

- 1. Nomination and Election of Officers (moved to beginning of meeting)
- 2. In recognition of the 15th anniversary of Lilly Ledbetter Act and in celebration of all women who pursue their rights under our equal pay laws, co-sponsor a webinar (which will spotlight Sandra Maas) with U.S. Dept. of Labor Women's Bureau in January 2024: Comm. Ijadi-Maghsoodi and Comm. Davis have been speaking with the U.S. Dept of Labor Women's Bureau of the Western district. The Commission has been asked to co-sponsor the webinar which will involve helping to decide what is involved in the webinar and will spotlight San Diego native, Sandra Mass.
 - a. Comm. Ijadi-Maghsoodi moves to approve the Commission to co-sponsor a webinar in recognition of the 15th anniversary of the Lilly Ledbetter Act and in celebration of all women who pursue their rights under our equal pay laws, for the webinar to take place in January of 2024 in coordination with the U.S. Department of Labor Women's Bureau. Comm. Farjood seconds the motion. The main motion passes with 9 in favor, 1 against (Comm. Cabrera), and 0 abstentions.
- 3. Committee Reports: Please refer to committee reports submitted with the agenda packet.
 - a. Civic Engagement no additional updates.
 - b. Policy Comm. Gutierrez asked if there was a date selected for the [KYR] Symposium [on 3/9/2024]. There is a Women's HIV Conference on March 9. 2024, so there is a potential conflict.
 - c. Governance Comm. Ijadi-Maghsoodi shared the Governance Committee did vote on a site and selected the date for the CSWG Know Your Rights Symposium for March 9, 2024.
- 4. Initiative Updates and Liaison Reports:
 - a. Women's Hall of Fame: Comm. Vásquez shared there was Women's Hall of Fame meeting in November of 2023 where they selected their candidates but did not disclose them because the candidates have not been informed yet.
 - b. Association of California Commissions for Women: no additional updates.
- 5. Commissioner Announcements:
 - a. Comm. Custodio Suero would like to pursue in 2024, elder care. Has resources to share and will email to Chair for distribution to all commissioners.
 - b. Comm. Gutierrez shared the San Diego Coalition for Reproductive Justice is holding their Annual Post Roe F fundraiser on January 24th at the Mingei International Museum from 5pm-9:00pm. This year's theme is Empowerment in Action: Harnessing Community Power for Positive Change. Will share the link with Comm. Vásquez who will distribute to all Comm.
 - c. Comm. Davis would like to have evening meetings to increase attendance. Maybe 2-4 meetings or quarterly.
 - d. Comm. Benton would like why meetings are noon on Fridays since it breaks up workdays and can be difficult. She would like to explore, if possible, a change to virtual or how many times we can attend virtually.
 - e. Comm. Vásquez shared the commission met earlier this year to discuss changing the

day and time since meetings used to be on Mondays at noon but commission votes changed it to noon on Fridays. The issue with having meeting in the meetings is that the Commission would have to pay for additional security to have building open. The Brown Act is why we cannot meet virtually with the exception with the attendance with cause.

- f. Comm. Davis would like to know if the Commission is tied to venue, do meetings have to be held at the County Administration Bulidng or can they be held at the Mission Valley Library who has security. Comm. Vásquez would like to discuss that at the retreat.
- g. Comm. Ijadi-Maghsoodi mentioned there is the possibility of cancelling the January 2024 regular meeting and having the retreat which is in the Code and By-laws.
- h. The Executive Committee will decide what works best and let the Commission know the information.

Since the last Commission meeting on December 1, 2023, the Governance Committee met on January 26, 2024:

1. Know Your Rights Symposium
