The impacts of this can be felt well beyond Santee or even the YMCA, it is felt throughout the trangender, LGBTQIA and communities beyond. While noting the significant reverberations of this dialogue is vital to healing and collaboration, it is equally important to commend those who have taken the right steps and moved in good faith. That is why we commend the YMCA, their staff and all those in the community who have engaged in the kind of positive dialogue that encourages healing and learning from each other as cornerstones. Their commitment to treating every member with dignity is an example to all of us.

As a Commission we know all too well the complexity of this work as we have had our own challenges as we learn to foster spaces of understanding, even when we disagree, and have civil discourse. But we want to make it abundantly clear that the HRC stands in solidarity with the LGBTQIA community and denounces any incidents of bias, bigotry, and racism.
