- B. County of San Diego request to Vacate a Flowage Easement on County of San Diego Tract No. 4736 – The Polo Club located on the North side of Gopher Canyon Road across from Vista Valley Country Club.
- C. County of San Diego Department of Parks and Recreation update with a list on the proposed “Naming Rights” program for trails and parks in the County.
- D. Moosa Creek Mitigation Bank – U.S. Army Corps of Engineers comments are requested by March 9<sup>th</sup> or 31<sup>st</sup>. Possible extension of deadline date.
