- d. Notification from Boulevard CPG about the new state law on permitting of renewables. AB-205 would place permitting for a solar photovoltaic, terrestrial wind and electrical generation powerplant over 50 MW in the hands of a state agency. Local agencies

may be allowed to comment on the application and environmental work, but the lead agency will be the **State Energy Resources Conservation and Development Commission.** The agency will also be in charge of permitting any energy storage system capable of storing 200 megawatthours or more of electricity and electric transmission lines to connect them to the grid. **Forwarded to group.**
