Approximately 100 Fallbrook residents attended in person and many more attended virtually. All were in opposition. Several spoke voicing their concerns. Several letters in opposition were also received. Project parcel is zoned 1DU per acre with an approved map for 22 homes. Some of the concerns voiced: Community character, dangerous road conditions, lack of any amenities, increased traffic, lack of infrastructure, not affordable. Developer left during public input and didn't stay to hear planning group member's input.

 - Should be required to obtain sales licenses/permits as well as other health and food related permits.
 - Should not be permitted to set up on any locations subject to the Fallbrook Design Guidelines where outdoor sales are prohibited due to narrow sidewalks and where pedestrians would be blocked from using the sidewalks.
 - Should not be permitted in any areas that do not have public restrooms.
 - Should not be permitted in the road right of way. Fallbrook's roads are often narrow and often line of sight is a concern.
 - Should only be permitted from the hours of 8am to dusk.
 - Should not be permitted in any areas where a vending cart would block or impede ADA access.
