 - Parking lot in front of library rezoning; current S86(parking only) to Village1 zoning. Positive input.
 - Tree planting in median(may impede planning community events on Main /Ave) – possibly move trees to sidewalk areas.
 - 2nd public review of draft Spring 2024
 - Present findings to FPG
 - Planning Commission Hearing summer 2024
 - Board of Supervisors Hearing Fall 2024
- 9. PDS24-MUP24-001. Presentation to gather Community and CPG input for a Major Use Permit for a proposed commercial retail center at 3080 Pala Rd (Hwy 76 @ Via Monserate). The project consists of a 2,500 sf car wash, 3,800 sf convenience store, 6,571 sf gas station and a 2,703 sf fast food drive thru restaurant for total of 15,574 sf of floor area on 2.63 acre site. Convenience store would be open 24/7. Drive thru restaurant would be open 7am to 11pm. Project would also include 54 parking spaces.  - Note: Large community attendance; full conference room in person and many participants on-line participants.
 - Dave Scott provided overview of proposed project
 - Approximately 1 hour and 10 minutes of public input at 3 minutes per person. Not one member of the community supported the proposal.
 - Chair Eileen Delaney opened PG comments providing stats from the SD County Sheriff's reports calls for service at 24 hour gas station in Fallbrook and Rainbow total calls in 3 year period 387.
 - 15,574 sq ft about 2 times the size of the largest gas station/restaurant in within Fallbrook/Bonsal footprint
 - Review of general project information provided by applicant and pointed out inconstancies of the responses (partial list).
 - Will project be a land use not existing in the surrounding neighborhood? Unknown entered on application
 - Will the project require new storm water drainage yes
 - o Will the project generate smoke, fumes, or odors Yes
 - Will the project affect traffic for horse riders, vehicles, pedestrian, including bicycles yes
 - o Is there any traffic congestion during commute hours at any nearby street intersection that will be substantially affected. No
 - Will the project cause substantial change in existing noise levels? No

- Will the project be more visible to the pun=blic than to its neighbors (larger than average not screened by landscape)
- This is a list of some of concerns raised by the public and planning group
 - o Is there really a need for this? There are 2 gas stations with a couple of miles either way on the 76. There are also drive through fast food restaurants on the 76 within a mile of proposed site. There are convenient store attached to the 2 mentioned gas stations.
 - Disruptive to the nearby residents.
 - o Noise
 - Lights/dark skies impacted
 - o Traffic
 - o Increase in crime
 - o Environmental sensitive area
 - Increase in drug activity
 - o Increase in Homeless population in the area
 - o Smell
 - o Litter & Graffiti
 - o Possible Gas leakage or spills from truck delivering gas
 - Prostitution
 - Alcohol sales
 - o Gas tankers will be unable to make turn in land out of property
 - Livestock impacted by noise and lights
 - o No sidewalks; increase in possible pedestrian accidents
 - Seems to be exact opposite of the way California government wants us to go: electric vehicles
 - o Water table is @ 11'
 - o Run off across the 76 right in to the San Luis River
 - o Fire evacuation will be almost impossible
 - o There is a community park going in across the way, doesn't seem to fit in

- Many residents of Fallbrook were present and many spoke. Bullet points of comments, questions and concerns from community:
 - o Why weren't FPG notified for 2.0
 - o How does the community benefit?
 - o This is obviously stacked revenue
 - How did the property zoning change without our input or the FPG vote?
 - o Storm water drainage requirements seems to be out of compliance

- o Lights are on all night, impacting neighboring residents
- o Fans are going 24/7 impacting neighboring residents
- Lowering property values
- o Alarms go off at all times of the day & night
- o Homeless camps have moved in
- o Fencing that is supposed to secure the area is very flimsy, no security on site concerns of crime increasing
- o Insurance is already almost impossible to get this is making it harder.
- Who actually controls the facility
- O Signs state if there is a fire the Fire Department is to stand down and evacuate the area. This will be a Hazmat situation. The evacuation area depends on many things, the number of batteries that are impacted, wind, temperature are a few.
- Water runoff is flowing through neighboring properties.
- Additional concerns raised by the FPG
 - o September 20, 2023 the facility in Valley Center had an incident and residents were evacuated and stayed evacuated for period of time.
 - o Fallbrook BESS is 2nd largest SDG&E facility in the County. Largest is in Imperial Valley in low density area.
 - o There have been 50 fires at BESS locations. Releasing chemicals into the neighborhood.
 - Hydrogen Chloride, fluoride and carbon monoxide in all chemical released on every fire
 - Who were the experts that conducted the EIR
 - The batteries that were involved were then deemed useless and put on pallets and new batteries installed.
 - Capstone is listed as the agency that will respond to a fire/accident. What is the response time?
 - Where is Capstone located?
 - Is it true that once a fire occurs the agencies are to "let them burn out on their"
 - Project is in San Lios Rey River water shed per FPUD Watershed map.
 The last free-flowing contiguous wild river in southern California –
 18million dollar Cal Trout fish passage at Sandia Creek. Also water is used for human consumption.
 - o What is the plan for battery end of life
 - o Address noise emitted from the air conditioning for batteries
 - o Address landscaping that will be addressed
 - o Does the project compromise the local neighbors fire insurance

Community members and FPG members want to know how we move forward? Can we stop the progress of the 2.0 site? Can we have the current 1.0 project removed?

The group from SDG&E had very little or no answers for us. As the Public Facilities Chair person I will be in contact with them and keep everyone updated. We are forming a

group to research what our options are to moving forward. Let me know if you are interested in helping. I will also keep everyone updated on this.
