There is now a real-time webcam network, which provides live views of high-traffic low water crossings throughout the County, including the one at Sandia Creek Road, near the Adobe Hill Winery and the Casa Tiene Vista Vineyard. These webcams are particularly essential during extreme flooding events, such as those we experienced on January 22 of this year. They allow the community and the public to monitor road conditions at these critical crossing points as water levels rise 24 hours a day. In addition to flood monitoring, these webcams can be used throughout the year for anything from current road conditions on a sunny day to keeping up with any nearby wildfire activity.
