a) PDS2023-MUP-23-008. Karve Ski Park. This is a proposal to modify an existing permit for outdoor recreation uses. It would convert the existing driving range to an outdoor, years around synthetic snow complex and recreational park at 26351 Centre City Parkway.

Matt Simmons of Consultants Collaborative address the group on behalf of the plan sponsor. The plan for the site involves the construction of a year-round ski park on artificial surface. He covered areas involving light pollution, noise pollution, traffic, signage and fire protection. Member Brower to conduct site visit with Matt Simmons and report back to the Sponsor Group. No further action was taken.

b) Mountain Meadow Village Center_ Thig a plan for commercial project at the southeast corner of Mountain Meadow Road and Center City Parkway No action. Applicants requested deferral of discussion to a later date.

Fencing — recommend/verify all fencing along Jesmond Dene, Centre City Pkwy and Tierra Libertia is wrought iron and of 6 foot height to include both the west side of parking lot and east side that adjoins the park. Discuss the 10 foot "noise attenuation" fence. This is chain link fence with a "cloth" noise abatement component. There will be vines on the backside to visual improvement to the neighbors. Verify removal of high golf fencing currently erected.

Parking lot -- verify new lot will be installed.

Traffic flow — a concern for the community as it is 55 MPH zone on Centre City. Current plans call for ingress/egress on Tierra Libertia and Jesmond Dene. Google Maps has you enter on Tierra Libertia even though the physical address is Centre City. Consider entry only on Tierra Libertia and exit only on Jesmond Dene. The current entry/exit on Jesmond Dene would clog traffic and a potential hazard as the entry is very close the interchange of Jesmond Dene and Centre City. Consider a deceleration/turn cut out for NB Centre City traffic as the potential for slow/stopped traffic for right turn onto Tierra Libertia with 55 MPH traffic would create a potential hazard. Right turn only for exit onto Jesmond Dene would seem logical and keep business traffic off of
