4. OPEN FORUM

• **Lisa Hodgson** Emmet Aquino, Parks and Recreation, will hold a public meeting at the end of January on zoom for their feasibility study for the development of an Off-Highway Vehicle Park (OHV). They are looking for a location throughout the entire County not just Jamul. There are OHV area parks like Corral Canyon which is an OHV Area run by the Forest Service, but there is no off-road vehicle park owned and run by the County itself. For clarification, residents contacted in Lawson Valley were asked only they were interested in selling, no offers were made. Lisa asked if we could get the APG to participate with a seat on their roundtable focus group.

- Ed Mollen said he did some investigation into how the County agencies handled the emergency response to the wildland fire on SR-94 over Thanksgiving. Ed spoke with various members of the Sheriff Department. While the response was very successful in that the fire was put out, there seemed to be a gap between different Sheriff departments on the execution time line for evacuations warnings and then orders. The Sheriff officers Ed spoke to had different recollections of the what was going on and at what time. There is a state-wide evacuation protocol, but in this instance, it may not have been completely successful. But again, overall this was well coordinated between County Fire/Calfire and the Sheriff Department. There was no loss of life and little fire damage to building structures. Our community is grateful for the excellent emergency response.

Paul Dombrowski said the APG will meet early in January to approve the final By-Laws, and he could bring up the idea of APG's participating in this study.
