#### F. Updates and Reports

1) Add a new Unincorporated Communities Advisory Board Member to the SANDAG Board of Directors – Kiki Skagen Munshi

# 4) PDS2023-LDREFL-00730; PDS2022-COMACC-000111; SYH Julian Medical, 2717 A Street, Julian; APN 291-072-09-00 – Josh Cardoso

The County has made a last minute decision to impose a Center Line Ordinance on the new Medical building plans. This is not appropriate for where the building is located. The ordinance would require sidewalks and a curb on a street where no/no other building or piece of land has one. The Medical Unit has been in plan check for eleven months but this requirement was added only about a month ago. The Architectural Review Board has said it believes a sidewalk and curb would be inappropriate in that place given its semi-rural character; the site is on the land that used to be an old stable with an open lot on one side and the town cemetery on the other. There are no sidewalks in Julian except on Main Street. The applicants repeated this in a lengthy phone call with the County to no avail. The Planning group agreed that the imposition of a sidewalk/curb requirement on the new Medical Clinic was unreasonable. Morales suggested we send a letter to the County with a copy to Superintendent Joel Anderson and that the applicants might want to reach out to Anderson as well. Munshi will draft a letter for Pat's approval. The County also wants the applicants to put in 48" box culvert instead of a 26" box culvert which is totally unnecessary, only on their property and won't work as well.
