- 1) Morales said she saw that Julian was being considered for putting in license plate readers. She heard that they seem to be put in with streetlights but we are a dark sky community. She will look into the issue and report at the next meeting.
- 2) Morales raised the possibility of meeting in the library. Nigro will look into it. Jones said acoustics were bad.
  - **E. Action items** (JCPG advisory vote may be taken on the following items)

#### 1). Save Palomar Mountain Tast Force (Jim Hamerly)

Two things we have in common: Appreciation for the back country and fear of wildfire. Hammerly is Chair of Palomar Mountain task force. They want to stop a major transmission line being put through Palomar Mountain. Our issue is fire and ecological impact. A line from Imperial Valley to feed LA County, nothing in between. Cost to build about 9 billion dollars. Horizon West refuses to disclose the exact route being considered until they apply, then the public has only 30 days to respond. Hamerly is here today, and speaking to all the CPGs, because if there is a fire on Palomar it is likely to impact Julian. Over the last twenty years many fires have been started by transmission lines. Palomar is at particularly high risk. There are alternate routes that would eliminate going through heavily forested areas. Assembly Bill 3238 will remove all CEQA requirements for all power

lines. It was killed in Appropriations Committee but will come back next year. Hamerly wants to get signatures sent in and gave us a sign and flyers. They need another 1,000 signatures. Morales said here in Julian we're seeing homeowner's insurance doubling/people losing insurance. Hamerly said his issue had no bearing on that and that this wouldn't have any impact.

### 1) Golden Nugget Trailor Park Background Permits (Rudy Rikansrud)

They are expanding but may not have ADUs for sewer. Morales asked if they intend to put a gate onto C St. Nelson said that this weekend there was gridlock on C St. They do plan to use C St. as an additional entrance. Need to put this on the agenda for next month.

# 2) Report from Architectural Review Board (Chairman Brown)

The ARB has written about violations by Julian Beer Company, Urban Feline facility on Washington Street, and sandwich boards on sidewalks. The County and Supervisor Anderson have not responded. Seifert said highway patrol could enforce getting rid of sandwich boards.
