The meeting was called to order at 7:00 p.m.

B. Public Comment:

Ms. Kelly McCormick spoke against cannabis licensing and efforts taken by Fallbrook Planning Group to protect private roads.

C. Action Items:

1. Site Plan Request-minor deviation to existing discretionary permit; 937 Sweetwater Rd; APN 584-511-19-00; Signage – Panda Express: the applicant is requesting approval of signage for new restaurant. Presenter: Lowes; Proponent: Tim Seaman

Lowes provided an overview of the project. The owner of the property, Brett Feuerstein mentioned that signage in the North had already been approved in a January 2020 meeting. Feuerstein provided the lighting plan. Harris pointed out that the total signage is nearly double the allowable amount of signage for our guidelines.
