The meeting was called to order at 7:02 p.m.

B. Public Comment:

Mr. David Berg stated that there is a dangerous situation for pedestrians with between the two bus stops along Sweetwater Blvd and Campo Rd. There should be a crosswalk there as there is a significant amount of traffic that travels at fast speeds.

C. Action Items:

1. **Presentation on** Green Streets Clean Water Program. Overview of program and what it means for Spring Valley. Our planning group may provide recommendations. Presenter: René A. Vidales, Program Coordinator, Watershed Protection Program, Dept. of Public Works, SD County.

Vidales provided an overview describing the environmental, community, and economic benefits. Pearson inquired about the funding source, grant writing, and how can we get the projects in the future. Pierce asked if there were any projects in the La Presa area. Custeau asked what the planning group

could do and Abrenica asked for the information from the brief in order to pass it onto others.

Member of the public Mr. Thomas Krejci asked if these projects could be solutions for the issue with flooding near the swap meet and how who would maintain the properties.

2. Site Plan Request-minor deviation to existing discretionary permit; 937 Sweetwater Rd; APN 584-511-19-00; Signage – Panda Express: the applicant is requesting approval of signage for new restaurant. This item was tabled at the October 26th to allow further research of previous minutes related to this project. Presenter: Lowes; Proponent: Tim Seaman

Lowes provided an overview and refreshed the group over what was previously approved in the March of 2020 meeting. Pierce remained concerned over the size of the frontage sign.
