The meeting was called to order at 7:00 p.m.

## **B.** Public Comment:

Mr. Chris Pearson spoke on three topics: 1. having CalTrans and SANDAG brief us on 125/94 interchange and ensuring the North lane from 125 is included, noting the trolley stop. 2. Questions on funding of Calavo Park and requesting a briefing from County Parks department addressing any design changes, funding changes, and how soon will it be done. 3. Land open for acquisition and requesting briefing from County real estate acquisition office.

Ms. Becky Rapp spoke against cannabis licensing and proposed cannabis ordinance.

Ms. Victoria Abrenica spoke about the upcoming Spring Valley Climate Action plan meeting to be held by the County on January 26, 2022.

Mr. Jesse Robles spoke about a recent vehicle accident on Sweetwater Road near the Smart N Final development, citing the prior discussion of this group regarding the safety concerns of this area.

Ms. Kelly McCormick spoke about concerns regarding cannabis ordinances and encouraged attendance at the board of supervisors meeting regarding the topic.

Ms. Judy Strang spoke about concerns with Supervisor Fletcher's continuing role as chair of the board of supervisors.

#### C. Action Items:

1. Discretionary Permit Application PDS-2021-STP-21-036; Miller Paving, 9236 – 9240 Olive Drive, Spring Valley; APN 504-021-32-00. Removal of existing Quonset Hut and construction of new 40X60 Metal Storage Building. Proponent: Dale & Stacy Miller, Presenter: Custeau.

Pierce raised concerns about trash enclosure, storm water drainage to street, and landscaping. Requested some trees to be placed on landscape strip.

Robles requested information on any checklist requirements for this type of proposal.

Custeau suggested the group approve fencing up to 8ft. Will communicate all concerns with the County and proponents.

Item is tabled until questions can be addressed.

2. Request for Site Plan Permit Exemption, Iron Auto Collision, 9450 Jamacha Blvd. APN 584-410-35-00. Addition of Paint Spray booth with exhaust vents. Proponent: Peter Ayala, Presenter: Eble.

Robles spoke about concerns regarding the property being brought up to standards and having the proponent examine and improve the property in accordance with Spring Valley design review guidelines.

Robles, Lowes, and Shaffer spoke about concerns with voting on the B-waiver today with the property as is, with existing property not following the design review guidelines as far as fencing, landscaping, and potentially other issues.

Property owner Mostafa Alani expressed they are willing to examine the design review guidelines and plan to work on property improvements but that it would not be able to be executed in a week's time.

Item is tabled until proponent returns with plans for site improvement.
