- D. ACTION ITEMS with designation as to whether there will be vote or not on the item:
- **1. Approval of Minutes:** 2/14/2023. Vote on this item.
- 2. Discussion About Dumping and Graffiti in Spring Valley / La Presa Alleys. Presenter: Kenneth Meltonote (DPW)
- The Proponent requested to pull the item because of a lack of grant funding.
- Jake Christie asked about why the project was pulled and shared some examples of problem areas.
- **3. 8868 Valencia Street, Site Plan, PDS2022-STP-22-027, APN 503-290-35-00**. Construction of 3 New Residential Buildings. Presenter is Lowes, proponent is Joseph Werner. Vote on this item.
 - Lowes shared a presentation with some highlights of the project.
 - The Proponent says he is compliant with the County's requirements for the ADUs.
 - Lowes recommended:
 - Driveway must be consistent with regulation for private roadways. Guest parking not shown.
 - Recommend Tot lot and

- Custeau: Asked about sidewalk requirements and the undergrounding of utilities. SNYDER shared with the Group that
 he is looking into the current rules for undergrounding requirements. The Proponent established that the project is not
 a division of property.
- Gibbons asked if the plans have been stamped or approved by the County. The Proponent confirmed that the plans have not been stamped.
- Lowes asked about the trash. Proponent says there is space for trash cans in the garage and that all tenants will be responsible for trash bins.
- Harris asked about plans and dimensions of the Project, as well as about the parking for the residents. The proponent clarified that the residents have space next to their units and that the fire department turnarounds will be painted red.
- Wallace questioned the timing of the project and how an ADU could be built on the property with no primary residence.
- The proponent stated that the rules indicate detached ADU's could be up to 1200 square feet and that the County
- Robles asked if the plans are consistent with the Spring Valley Design Review Guidelines
- · Custeau shared that the Design Review Guidelines may now be outdated because of new legislation.
- Wallace asked
- Harris shared that he is also used to Projects being tested against the CPG Design Review Guidelines. Harris recommended the proponent include more architectural relief.
- Robles recommended the Group include in the motion that the project make the changes

 - Mona from Assemblymember Weber's introduced herself to the group. She shared that her Member just released her legislative packet with 23 bills. The member will be participating in at least 6 public events. Board members asked about upcoming legislation that would impact taxpayers. CPG members also asked for support for the 125/94 interchange, specifically for the Assemblymember to work with all levels of government and elected officials to find funding for the project. Some CPG members asked for the Assemblymember to help make public transportation more accessible and to help address climate change. Moana shared that her member offers a period of time a year where resident can suggest topics for legislation.
 - Eugenio shared that the Sewer district is seeking feedback on proposed rates.
