Administrative Items

Co-Chair Steve Stonehouse brought the meeting to order at 7:00 Item #1: Roll call: Secretary Liz Stonehouse called the roll by name. Steve Stonehouse co-chair, Harriet Taylor co-chair, Daryl Hern, Uwe Werner, Mark Kukuchek, Tony Tieber, Judy Tieber, Daniel Diaz, Shane Parmaly, John Taylor, Sheri Todus, Michael Garrod, Michael Clowers, Diane Carter.

Item #2: Approval of minutes. Uwe motioned to accept. Judy seconded. Passed: with 13 votes. Diane abstained. Shane and Michael Garrod came later in meeting.

Item #3: Chair motioned that item #6 be taken after item #3 because Victor is not here but Michael Aguliar from Road Resurfacing is. Sheri seconded. 13 voted aye as Shane and Michael Garrod came after this vote.

Item #6: After a long and detailed discussion about how roads are chosen and what the criteria is actually used for road resurfacing, Planning Group had several roads of lengths of road they wished to add: Sweetwater Manor, all four roads, Avenida Palo Verde, which was not on the list. Action Item

Item #4: PDS2019-MUP-04-002-M3 Easement vacation Carriage Hills Estates, 5771 Sweetwater Road. Jeff Phair presenting (Robert Hingtgen, planner) After a discussion of maps, which were circulated, concerning which areas were those intended for vacation, Mark moved: That Planning Group should allow the vacation of items one through eight, skip nine and allow 10. Diane seconded. Vote by roll was unanimous.

Non-Action Items

Item #5: PDS-2019-TM-5632 Tentative map, 19 parcels at 6645 Jonel Way. Alonzo Gonzales presenting. (Denise Russell, planner): Problem number one, the planner did not come to meeting.

Problem number two, the person who did come knew nothing about what was going on.

After discussion, the consensus, not necessarily in order, was the new amount of traffic on Jonel Way; when the scoping letter was to come out, then the time frame for building these homes. After that came the trail easement and whether emergency vehicles would have enough room to turn around in a gated community. Mark explained how to indemnify for trails. Sheri noticed that Bonita Meadows Lane, a private road, had an easement of 30 feet.

Harriet agreed to contact Sarah Agassi and set up a meeting.

At this time this subject would return on the next agenda.

Item #7. Liz with update on Chair's meeting February 9, 2019: These issues were discussed at the meeting; ADU-Additional Dwelling Units-County to waive fees but still require septic tanks to meet standards). Property owner must live in site. At this time rentals cannot be less than 30 days.
