**Administrative Items**

Co-Chair Steve Stonehouse brought the meeting to order at 7:00PM, Bonita-Sunnyside Fire Department training room.

Item #1: Roll call: Secretary Liz Stonehouse read the roll. Steve Stonehouse co-chair, Harriet Taylor, co-chair, Michael Clowers, Daryl Hern, Diane Carter, and Sharmaine Estolano, John Taylor, Mark Kukuchek, Tony Tieber, Judy Tieber, Daniel Diaz, Shane came late.

Excused: Uwe Werner, Michael Garrod

Item #2: Approval of minutes of 8/2/ 2022. Move to approve: Judy Tieber: Second, Sharmaine. Passed, Aye:12, Noes:0, Excused: Uwe Werner. Shane not here yet.

Item #3: Opportunity of others to speak on items not on the agenda: Harriet told us that She and Judy had given out flyers at the Bonitafest events and that they would do it again at the melodrama.

**Non-Action Items**

Item #8: taken out of order by consent: Audrey Hamilton presented us with information on the County Community Agreement. After listening to the information it seems that: developers must seek agreement from Planning groups to go forward. That there will be extended outreach to communities concerning large developments and land use. The objections to this were that private parties were ruining roads in our area and that the County doesn't seem to want to know what we need.

**Action Items**

Item #4: To reimbursed Harriet Taylor \$400.00 for rental of the Christian Church in September. Move to approve Diane, second Mark. Approved, 13 Voting, Excused: Uwe and Michael Garrod.

Item #5: Abandoned.

Item #6: To be taken in three votes: No overnight parking on Plaza Bonita Road: After discussion: Sweetwater Community Planning Group recommends No overnight Parking on Plaza Bonita Road with a recommendation that San Diego County establish a safe overnight parking zone in South County: Diane Second Judy. Passed with 11 voting aye: 2 voting Noe: Shane, Stephen: 2 excused: Uwe and Michael Garrod.

After discussion on Item two: This in two votes. After discussion on whether to put no commercial parking signs on San Miguel Road: Judy motioned, Diane

seconded. . Motion failed: 6 aye: 7 noe: Liz, Michael Clowers, Mark, Harriet, Shane, Stephen, Sharmane: Excused: Uwe, and Michael Garrod.

Motion: SCPG requests the County to put up No Commercial Overnight Parking on the North Side of San Miguel Road from Alameda to the end of the wide strip just before Conduit. Diane, second Judy. This passed unanimously with 13 voting, two excused: Uwe Werner, and Michael Garrod.

Item three on the list: Motion: County needs to create a sidewalk between Siempre and Frisbie Street, as the pathway there is eroded so far as to make it unsafe to walk along it. The County should also look into Safe sidewalks to school. Diane. Steve Seconded. Passed with 13 voting aye: no noes: and two excused, Michael Garrod and Uwe Werner.

Item #7: PLDO 2022-2023 list: Mark Kukuchek presenting.

The changes to last year's PLDO are as follows: Mark motioned: That #1 should stay: Complete the section of Trail #45. Add a new permanent Restroom to the Bike Skills Park on San Miguel Road, Repair North side entrance corner of Sweetwater Road entrance to Bonita Golf Course. Motion made by Mark seconded by Diane. After more discussion, the County owns the easement. Vote: Thirteen aye: no ones, Two excused: Uwe Werner and Michael Garrod.

Item #9: Harriet with Community updates: Bonitafest Melodrama starts tomorrow. Mike Clowers is on the Traffic Committee. Anyone who misses three meetings without excuse can be removed.

Item #10: Andrew Harvey with County updates: He stated that he would follow up with our safety concerns. That we should be getting more CHP presence in the Valley. There is a housing Summit agreement in place to allow 10,000 houses throughout the County. Tomorrow there will be a fireside chat about pollution. The Tieber Trail is on the list. Homeless is now a public health concern.

Item #11: not on agenda, Announcements: There will be a Poker Ride on the 22<sup>nd</sup>. Horses and bicycles are both invited. Check in is at 9: AM. There will be lunch and prizes. Contact BVH for more information.

There is a golf tournament November 4 at Chula Vista Golf Course. On the 5 the Gathering of Nations exhibit starts at the Museum.
