From the draft of the Ordinance: New construction where the aggregate landscaped area is 500 square feet, or more or modified landscape that in the aggregate totals 2,500 square feet, or more or A new single family residence served by a public water purveyor within the San Diego County Water Authority will be required to under project goals, w-1.2: "Reduce outdoor water use in new and existing residential and non-residential landscaping 40% from 2014 levels*Approximately 24% reduction in residential and 7% reduction in non-residential from today's levels."
