North County Metro CPG Project Priority List Transportation Improvement Projects: The County would like input on creating a priority list of road improvement projects per the discussion last month and from a meeting with members of the community held on June 14th.   - Road Reconstruction/Reconfiguration/New Roads: Improvements include adding and/or modifying street lighting, lanes, turning lanes, roundabouts, or bike lanes to improve safety and/or increase roadway capacity.
  - 2. *Bridges Repair/Reconstruction:* Improvements include adding and/or modifying street lighting, lanes, or bike lanes to improve safety and/or increase bridge capacity.
  - 3. Sidewalk/Pathways/Pedestrian Access Ramps: Improvements include sidewalks, pathways, and ramps that promote safety and walking in the community.
  - 4. *Drainage:* Improvements include corrections to storm drain problems on roadways or dip sections.
