1. Title: Request for Feedback on Draft Environmental Review Guidelines

Project Description: The County of San Diego is pleased to share the draft of our Environmental Review Guidelines (Guidelines) for review. These Guidelines are designed to guide SDAPCD staff in fulfilling the requirements of the California Environmental Quality Act (CEQA) and to assure the public that environmental impacts related to SDAPCD actions are thoroughly and consistently addressed.

The Guidelines will be presented to the SDAPCD Governing Board for approval on November 14, 2024. There will also be an opportunity for interested members of the public to provide feedback on these Guidelines during the SDAPCD Planning and Policy Committee Meeting scheduled for October 10, 2024. As a key stakeholder, the County is encouraging TOVCSG to review the draft document and provide any feedback or suggestions no later than October 25, 2024. 2. Title: Request for Public Input on Buena Creek MOVES

Project Description: The County of San Diego Planning & Development Services (PDS) invites you to attend a public meeting to discuss Buena Creek MOVES - part of the County's Community Based Transportation Program. Buena Creek MOVES intends to bring Buena Creek residents, community organizations, and County staff together to identify transportation challenges and needs in the local community. The Buena Creek MOVES plan will serve as a visioning document designed to enhance transportation options and accessibility within the Buena Creek focus area to improve mobility, safety, and connectivity for all types of transportation. In this meeting we will discuss project goals and objectives, existing conditions, and potential mobility improvements and programs to respond to your needs. PDS is hosting this in-person, public meeting to receive your input on October 15th, 2024 at 6 pm.

As a community-based effort, the development of the Buena Creek MOVES plan relies heavily on the collaborative engagement of a variety of partners, including community individuals, stakeholders, and community-based organization.

Throughout the development of this plan, the County will take the lead in facilitating engagement to hear more about the experience of moving around in the Buena Creek area. The engagement process will collect community input on areas of concern to determine the highest priorities for mobility improvements.

3. Title: 2024 PRO Housing Grant Funding Opportunity

Project Description: The County of San Diego (County) is releasing a draft funding application to the U.S. Department of Housing and Urban Development (HUD) funding program titled <u>Pathways to Removing Obstacles to Housing (PRO Housing)</u>. This application proposes \$2 million to facilitate innovative approaches to housing production.

If awarded, the County will use the funding to continue the Development Feasibility Analysis (DFA). The DFA identifies factors that impact development (e.g., lack of infrastructure, small lot size, or zoning) down to the parcel and how to best facilitate housing development near transit, jobs, and public facilities. Through this study, we will identify strategies to meet the region's critical housing needs and support healthy, resilient, and equitable communities. The County's draft application describes the need and vision for the DFA, implementation efforts, and the long-term effect of the proposed use of funds. CITIZENS NEEDED TO SERVE ON COMMUNITY ADVISORY BOARD

The Twin Oaks Valley Community Sponsor Group, a County appointed citizens advisory group that advises the County of San Diego on land use matters in the Twin Oaks Valley Planning Area is seeking applications for membership.

What is the Twin Oaks Valley Community Sponsor Group?

This Group is one of 28 planning and sponsor groups in the unincorporated areas of San Diego County. Its purpose is to be an information link between the community and the County of San Diego on planning and land use matters in the local community. The group provides a public forum for the discussion of issues which are important to the community and all meetings are open to the public, held in a public place, and the agenda published according to Brown Act provisions.

Members are appointed by the Board of Supervisors and serve in an advisory capacity only to San Diego County Department of Planning and Development Services. Group members serve on a volunteer basis for a term of four years.

Members must be registered voters, and either be residents or own property in the Twin Oaks Valley Planning Area. Members to attend one evening meeting, held from 7-9pm, on the third Wednesday of each month. Members receive yearly training and take periodic online training as required for public officials.
