 - Gary and Debbie White: House gets flooded almost every time it rains. Knocked out all the fencing. Sometimes big rocks hit the house.
 - Katherine Hankins: Never had any problems before Mr. Hakim started all the work. Rocks broke the fence. The earthen berm is just diverting down the hill. There is nothing permanent there to prevent the erosion and damage down the hill. Construction in the middle of the night.
 - Donna Andersony: Everything should be taken down and rebuilt.

- Larry Morshow: Going to need about \$30,000 for a retaining wall. Concerned with truckloads of rocks that will damage Alto Drive.
- Conway: Concerns will impact to sewer lines
