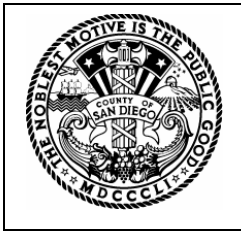

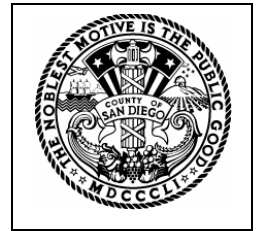

**PROJECT REHEARING INFORMATION:** The JVR Energy Project was discussed and voted on by the Planning Commission at the July 9, 2021 Planning Commission hearing. Although the correct conference ID number was provided in the participation instructions on the Planning Commission website and was correctly stated during the Planning Commission Hearing on July 9, 2021, the information provided during the live stream of the hearing on how to provide public testimony via teleconference did not include the correct public participation conference ID number. Due to the incorrect information provided on the live screen, at least two members of the public reported being unable to participate and have requested that the Planning Commission should vote on whether to reconsider and/or rehear the item on August 6, 2021, and then open the public hearing, hear the item again, and provide a recommendation.

**PROJECT DESCRIPTION:** This is a request for the Planning Commission to evaluate the JVR Energy Park Project which consists of a Major Use Permit and Fire Protection and Mitigation Agreement for the construction, operation, maintenance, and ultimately the decommissioning of a solar energy facility with on-site battery storage for the production of 90 megawatts of electric power to be delivered to an existing San Diego Gas & Electric transmission line. The project will include photovoltaic modules mounted on support structures, inverter/transformer platforms, an on-site substation, an overhead transmission line and a battery energy storage system. The project will also include internal access, site access driveways, perimeter fencing, low-level shielded lighting, fuel modification zones, six water tanks for fire protection, and associated site infrastructure to support the solar energy generation and storage facility. Grading is expected to be balanced on site, with approximately 280,000 cubic yards of cut redistributed across the site. Access to the Project site is provided by Old Highway 80 and Carrizo Gorge Road. The Project site consists of 24 parcels and includes right-of-way easements for Old Highway 80, SDG&E easements, and an easement for the San Diego and Arizona Eastern Railway. The project site is subject to the Village General Plan Regional Category for the majority of the 1,356-acre site area. The Project development footprint will be located primarily on land designated as Specific Plan Area. The proposed uses are consistent with the Zoning and General Plan Land Use Designation of the property established by the General Plan.

The Planning Commission will recommend to the Board of Supervisors whether to approve or deny the MUP and Fire Services and Mitigation Agreement, and whether to adopt the Environmental Impact Report (EIR) in accordance with CEQA.

LOCATION: Carrizo Gorge Road, South of Interstate 8, within the Jacumba Subregional Group Area of the Mountain Empire Subregional Plan Area. ENVIRONMENTAL STATUS: The project has been reviewed in compliance with CEQA. An Environmental Impact Report was prepared for the project and was available for public review from October 8, 2020, through December 7, 2020 (59 days).
