A RESOLUTION OF THE SAN DIEGO COUNTY)  
BOARD OF SUPERVISORS ADOPTING )  
GENERAL PLAN AMENDMENT (GPA) 12-003 )

ON MOTION of Supervisor \_\_\_\_\_, seconded by Supervisor \_\_\_\_\_, the following Resolution is adopted.

WHEREAS, pursuant to Government Code Sections 65350 et seq. [General Plan Amendment and Zoning Implementation Guidelines, GPA 12-003 has been prepared, being the second amendment to the County Regional Land Use Element in Calendar Year 2013; and

WHEREAS, GPA 12-003 has been prepared by the County of San Diego and consists of an amendment to the Regional Land Use Element, Mountain Empire Subregional Plan (Boulevard Chapter) and Borrego Springs Community Plan; and

WHEREAS, the Planning Commission has made its detailed recommendations concerning the above item; and

WHEREAS, the Planning Commission recommends that the Board of Supervisors review and consider the information contained in the Final Environmental Impact Report dated January 2013, on file with the Department of Planning and Land Use prior to making its decision on the project; and

WHEREAS, on April 13, 2012, the Planning Commission, pursuant to Government Code Sections 65351 and 65353, held a duly advertised public hearing on GPA 12-003 and held additional hearings on April 27, 2012, July 20, 2012, October 5, 2012 and October 19, 2012; and

WHEREAS, on \_\_\_\_\_, 2013, the Board of Supervisors, pursuant to Government Code Section 65355, held a duly advertised public hearing on GPA 12-003; and

NOW THEREFORE BE IT RESOLVED that the Board of Supervisors takes the following actions:

1. Find that the Board of Supervisors has reviewed and considered the information contained in the Final Environmental Impact Report dated \_\_\_\_\_, 2013, on file with the Department of Planning and Development Services prior to making its decision on the project;

2. Find that the Board of Supervisors adopted the Findings Regarding Significant Effects for the Project pursuant to CEQA Guidelines section 15091.
3. Find that significant and unavoidable impacts of implementing the project are acceptable due to specific benefits detailed in the Statement of Overriding Consideration dated \_\_\_\_\_, 2013;
4. Approve GPA 12-003, which consists of an amendment to the Regional Land Use Element, Mountain Empire Subregional Plan (Boulevard Chapter) and Borrego Springs Community Plan as shown on Exhibit A (Boulevard Chapter) and Exhibit B (Borrego Springs).

BE IT FURTHER RESOLVED that the amended documents shall be endorsed by the Chair and Clerk of this Board and by the Chair and Secretary of the Planning Commission.

BE IT FURTHER RESOLVED that this Resolution shall take effect and be in force from and after 30 days after its adoption.
