CIRCULATION OF THE DRAFT ENVIRONMENTAL IMPACT REPORT FOR THE SOCIALLY EQUITABLE CANNABIS PROGRAM

January 30, 2025

NOTICE IS HEREBY GIVEN that the County of San Diego Planning & Development Services (PDS), as Lead Agency, is circulating for public review a Draft Program Environmental Impact Report (PEIR) (State Clearinghouse No. 2023090330) for the Socially Equitable Cannabis Program, in accordance with the California Environmental Quality Act (CEQA). PDS is seeking public and agency input on the Draft PEIR and related amendments to the San Diego County Code of Regulatory Ordinances and the San Diego County Zoning Ordinance.

SOCIALLY EQUITABLE CANNABIS PROGRAM. The County is developing a Socially Equitable Cannabis Program (Cannabis Program) as directed by the Board of Supervisors on January 27, 2021. The proposed Cannabis Program would apply to the unincorporated areas of the County. The Cannabis Program will allow for and establish a permitting and licensing system for new commercial cannabis activities, including retail, consumption lounges, cultivation, manufacturing, distribution, testing, microbusinesses, and temporary events. Furthermore, the Cannabis Program will contain and be informed by a Social Equity Program which will provide greater opportunities for individuals negatively or disproportionately impacted by cannabis criminalization and the War on Drugs. Adoption of the Cannabis Program will require amendments to the San Diego County Code of Regulatory Ordinances and the San Diego County Zoning Ordinance to establish licensing and operational regulations for a range of cannabis cultivation and non-cultivation uses authorized under state law.

The County is considering 5 alternative variations to the Cannabis Program, including the no-project alternative. Alternative 2 (proposed project), Alternative 3 (expanded regulations), Alternative 4 (outdoor cannabis cultivation prohibition), and Alternative 5 (maximum 1-acre outdoor cannabis cultivation) would involve the same 3 components of the Cannabis Program (Social Equity Program, cannabis regulatory amendments, and a cannabis licensing and permitting system). The project alternatives differ in regard to the definition and buffer distance from sensitive uses, allowed license types, and allowed maximum outdoor cultivation canopy. The Draft PEIR evaluates each of these alternatives at an equal level of detail.

The Draft PEIR identified potentially significant environmental impacts to the following issue areas:

- Aesthetics
- Air Quality
- Biological Resources
- Cultural and Paleontological Resources
- Greenhouse Gas Emissions and Climate Change
- Hydrology and Water Quality
- Noise
- Transportation
- Utilities and Service Systems

In compliance with CEQA Guidelines Section 15087(c)(6) the lists specified under Government Code Section 65962.5.5 related to hazardous waste conditions identify known hazardous material and contamination sites in the county that are listed in Draft PEIR Tables 2.10.2, 2.10.3, and 2.10.4.

PUBLIC REVIEW PERIOD AND MEETINGS. Comments on the Draft PEIR must be received no later than **March 31, 2025, at 4:00 p.m. (a 60-day public review period).** Staff will be hosting public meetings to solicit comments on the Draft PEIR.
