MEETING MINUTES

Date: Tuesday, October 1, 2024 Time: 7:00 p.m.

Place: Witch Creek School (2188 4th Street, Julian CA)

- I. Roll Call The meeting was called to order at 7:00pm. In attendance: Chair Tony Romano, Matt Kraemer, Brian Steutel, Pat Brown. Absent: Kiki Munshi, David Shorey (excused.)
- II. Approval of Agenda It was Moved by Steutel and Seconded by Kraemer that the Agenda be approved.

III. Approval of previous meeting's minutes – The Minutes of the September 10th, 2024 were presented.

It was Moved by Steutel, Seconded by Brown that the Minutes of the September 10th, 2024 meeting be approved.

- IV. Public comment for items not on the agenda: Ivan Solano (760) 917-9369, proposed erecting 2 columns of natural, granite rock on either side of the entrance to property at 2411 C. Street (the driveway for this property is actually located on 2nd Street and this is where the columns will be. The board appreciated this notification and even though Mr Solano was not on the agenda, the board agreed to put this issue on November agenda and approved it retroactively. Mr Solano was told that he could begin the project immediately.
- V. New Business Action Items
 - A. 2902 Washington Street; Urban Feline Andres Zepeda; Multiple violations;
 - -Property owner not present. Kraemer reported that he had talked to Brad Hernandez from County Code Compliance and that Brad requested a letter from the ARB stating areas of non-compliance and that he (Brad) would add these items to the major use permit that the property owner is seeking. Chair Romano reported that he will present the letter to Brad Hernandez.

B. Golden Nugget Trailer Park. Street Lights

-Property owner not present. Brown reports that there is currently no work going on at this site and that he believes that the County has ordered the owner "to stop." Chair Romano has called the property owner and left another message stating that the newly installed streetlights are not compliant, but still no response. Chair Romano will now email Brad Hernandez and request that "Compliant Lighting" be part of the requirement of the site plan.
