Description:

The Leonard and Grace Smith, George Eckel House is a single-family residence constructed in 1953 to 1954 with an addition in 1962 in the Post and Beam/Modern architectural style. The applicant is requesting designation under criteria V(b)(2) and V(b)(3) of the Local Register.

Today's Action: Consider the application for the Leonard and Grace Smith, George Eckel House for designation to the County's Local Register and participation in the Mill's Act Program and make a recommendation to the Director of Planning & Development Services.

Staff Recommendation: Staff recommends participation in the Mills Act Program and placement of the Leonard and Grace Smith, George Eckel House on the Local Register of Historic Resources as Landmark Number 2019-003. The period of significance for this resource is proposed as 1953 to 2012 as that is the construction completion date for the residence. Staff finds this resource to be significant under the County's Local Register of Historical Resources Ordinance 9493 under criterion V(b)(2) and V(b)(3).
