What is the North County Plan?

- Tool to help the County and Landowners comply with existing endangered species laws
- Large-scale habitat conservation program

How does it work?

- Balances protection of biological resources with development and infrastructure
- Provides long-term regulatory assurances
- Streamlines access to permits for the County and Landowners













North County Plan is an HCP/NCCP


- Provides Federal and State Endangered
 Species Permits (Incidental Take Permits)
 - Federal permits: Habitat Conservation Plan (HCP)
 - State Permits: Natural Community Conservation Plan (NCCP)
- Permits available for use by County and Landowners everywhere the County has land use jurisdiction
- Part of the Multiple Species Conservation Program (MSCP)

Unincorporated County

- North County Plan
- South County Plan
- East County Plan

Incorporated Cities

- MSCP (south coastal)
- MHCP (north coastal)









Regional HCPs and NCCPs

Common tool to provide permits and solve endangered species conflicts

- Where development pressure and listed species overlap
- 715 HCPs (2020)
- 16 NCCPs (2019)






Federal and California Endangered Species Acts

- Purpose: Conserve and protect plant and animal species at risk of extinction and conserve and protect the ecosystems upon which they depend
 - Including species already listed as threatened or endangered, AND those in decline that might become listed in the future
- What does that mean?
 - Cannot "take" listed species or remove habitat of a listed species
 - "Take" generally means to harm, harass, or kill a species and can include removing habitat
- How can development projects or other activities move forward when impacting listed species and habitat?
 - Obtain an Incidental Take Permit
 - Federal permit: Habitat Conservation Plan (HCP)
 - State permit: Natural Communities Conservation Plan (NCCP) or 2081 permit

Board of Supervisors' Direction

- In October 2020, the Board voted unanimously to direct County staff to proceed with preparation of an HCP/NCCP for the North County Plan Area
- Board also directed that Rancho Guejito not be part of the Plan
- Board's direction was informed by feedback from:
 - North County Plan Stakeholder Working Group
 - Individual North County Plan Stakeholders
 - General public, Community Planning Groups & Private Property Owners
 - Wildlife Agencies (USFWS and CDFW)
- In Spring 2021, the County contracted with ICF to move forward with Plan development





Plan Area Revisions


- Why reevaluate the Plan Area?
 - Replace habitat and species occurrences found on Rancho Guejito
 - Expand conservation areas and regional linkages
 - Provide mitigation exemptions to additional property owners
- Criteria used to draw Plan Area boundaries:
 - Watersheds
 - Baseline Preserve lands
 - Parcels and specific ownerships
 - Connectivity
 - Vegetation and covered species distribution
- Four scenarios were evaluated






Revised **Plan Area Boundary**




North County Watersheds




Where Does the County Have Land Use Jurisdiction?

- San Diego County area:
 2.9 million acres
- Unincorporated area:2.2 million acres
 - Land use jurisdiction: over 772,239 Acres or 35%
- North County Plan:
 - Total Plan Area: 690,376 acres
 - Permit Area (Land use jurisdiction): 407,788 acres (59%)





Revised Permit Area



Plan Area/Permit Area Adjustment Advantages

- Adds large blocks of undisturbed habitat to the Plan Area
- Expands east-west connection across the full extent of the North County Plan Area
- Greater ability to address climate change with elevation gradients
- Connects Ramona to the rest of the Plan Area
- Includes important critical habitat and core populations for a number of key species
- Offset the loss of habitat conservation opportunities on Rancho Guejito
- Expands Covered Species list by a reasonable number (4 species)
- Adds important County DPR Preserves (Santa Ysabel, Vulcan Mtn) to baseline preserves
- Includes opportunities for coverage of residential and agriculture expansion in rural lands





Preserve Design Approach

- Merge North County Pre-approved Mitigation Areas (PAMA) and East County Focused Conservation Area (FCA)
 - Rename: Priority Conservation Area (PCA)
- Advantages:
 - Maximizes value to previous work to date
 - Preserve boundaries previously vetted
 - Fastest and most cost-effective strategy
 - Solid science foundation from North and East County preserve design methods




What is a Priority Conservation Area?


- Identifies areas with the highest biological value and best areas to assemble a habitat Preserve
- The North County Plan will set forth policies and approaches to encourage preservation within Priority Conservation Areas (PCA)
- While development is not restricted within the PCA, the mitigation requirements incentivize conservation within the PCA
- The PCA will also serve as a map to guide conservation actions towards areas within the PCA using County, State, and Federal funding sources

What Species Are Covered by the North County Plan?

Covered species are identified because they meet the following criteria:

- Occur in the North County Plan Area
- Already listed as threatened or endangered, or are declining and may be listed in the future
- There is a likelihood of impact ("take") to the species from future projects or operations and maintenance
- The species is understood well enough to evaluate the potential "take" and to create a conservation strategy to offset and balance that "take"
