SUBJECT: UPDATE ON THE BUDGET FOR COMMISSION ACTIVITIES

BUDGET STATUS UPDATE:

As of October 10, 2023, a total of \$1,474,139 has been expended from the IRC’s total budget of \$1,600,884. Fiscal Year (FY) 2022-23 had a budget of \$503,644, of which a total of \$189,996 was expended, which is reported by the County’s Oracle financial system. In order to meet financial obligations for FY22-23, an additional \$80,000 was provided by the County, as shown in Attachment C, bringing the total amount of funds provided to \$1,600,884. All expenditures were anticipated.

Below is a high-level summary of the budget:

Current Budget:	\$1,600,884
Expenditures to Date:	\$1,474,139

Additional Expenditures Projected in FY23-24:	\$337,990

Below are additional details regarding updates to specific budget line items:

- **Contracted Services: Additional Legal Counsel:** This includes legal services under the Professional Services Agreement with Colantuono, Highsmith & Whatley, PC, as authorized by the IRC on March 28, 2022 (Agenda Item 9). Of the total \$500,000 anticipated allocation, \$448,394 has been expended. It is anticipated that an additional \$280,000 will be needed for further legal services.
- **Contracted Services: Demographic/Mapping:** This includes demography services from Maul Foster & Alongi, Inc., doing business as FLO Analytics. Of the total FY22-23 allocation, \$19,572 was expended. The actual total amount includes a surcharge of 0.62% for FY 2022-23 for recovery of the County’s contracting and administrative costs. Projected FY23-24 Demography expenditures are for any demography utilization during the appellate brief writing stage.
- **Contracted Services: Information Technology (IT): Equipment** includes monthly charges from the County’s IT contractor for network access and email addresses. **Other** includes single-

use charges for help-desk usage. Ongoing monthly costs to maintain network access and email addresses will be incurred while these services remain active. Both **Equipment** and **Other** include Cross Functional Services fees, which are calculated based on actual usage from two fiscal years prior (FY21-22 for the current fiscal year). As FY21-22 was the height of the IRC's IT usage, the current Cross Functional rate has increased. Projected FY23-24 IT expenditures are calculated using August 2023 expenditures.

- **Translation and Interpretation** actual total amount includes paid invoices from Hanna Interpreting Services LLC, and Accent on Languages, Inc., for translation of IRC meeting agendas based on the translation requirements of the California Elections Code. This amount also includes a surcharge of 0.62% for FY 2022-23 for recovery of the County's contracting and administrative costs. Projected FY23-24 Translation and Interpretation expenditures are approximated at \$400 per meeting for four meetings, totaling \$1,600.
- **Other Services and Supplies** total amount of \$112 includes printing fees, parking fees, and miscellaneous fees for the IRC's in-person meeting.
- **Projected Budget Deficit:** Staff is working with the Finance & General Government Group Executive Office to identify the funding source for projected budget deficit. The County will continue to fund the IRC activities.

OVERVIEW:

SUBJECT: DISCUSSION AND POSSIBLE APPROVAL OF AMENDMENT TO THE CONTRACT FOR LEGAL SERVICES WITH COLANTUONO, HIGHSMITH & WHATLEY TO INCREASE “NOT TO EXCEED” AMOUNT TO \$800,000 AND TO AUTHORIZE THE CHAIR TO EXECUTE SUCH AMENDMENTS ON THE COMMISSION’S BEHALF CONSISTENT WITH THIS AUTHORITY

OVERVIEW:

On March 10, 2022, the IRC appointed Holly Whatley of Colantuono, Highsmith & Whatley, PC as the Interim General Counsel and authorized the Chair to sign the agreement. Then, on March 28, 2022, the IRC approved an amendment to the contract for legal services with Colantuono, Highsmith & Whatley to increase the “Not to Exceed” amount to \$500,000 and authorized the Chair to execute such amendments on the Commission’s behalf consistent with this authority.

Counsel has reached the maximum compensation allowable in the current agreement, therefore a Second Amendment is necessary. With the need for additional ongoing legal services, it is recommended that the IRC take the following actions:

1. Approve an Amendment to the Agreement to increase the “Not to Exceed” amount to \$800,000; and
2. Extend the term of the agreement through June 30, 2025; and
3. Authorize the Chair to execute such amendment on the Commission’s behalf consistent with this authority.

SECOND AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT
Independent Redistricting Commission

THIS SECOND AMENDMENT TO AGREEMENT is made and effective July 1, 2023, between the County of San Diego, a political subdivision of the State of California on behalf of the COUNTY OF SAN DIEGO INDPENDENT REDISTRICTION COMMISSION (“Commission”) collectively referred to as "County," and Colantuno, Highsmith & Whatley, PC ("Counsel").

RECITALS

A. On or about March 9, 2022, County and Counsel entered into a Professional Services Agreement ("Agreement,") in which Contractor agreed to provide legal services to the County of San Diego Independent Redistricting Commission (“Project”).

B. On or about April 4, 2022, County and Counsel entered into the First Amendment to the Agreement to extend the Maximum Compensation and the Term of the Agreement.

C. The Commission wishes to further extend the Maximum Compensation and Term of the Agreement.

NOW THEREFORE, the parties agree as follows:

1. The Agreement shall be amended to replace Section 2.4 in its entirety to state:

2.4 Maximum Compensation. The maximum compensation under this Agreement shall not exceed Eight Hundred Thousand dollars (\$800,000) (the “Not-To-Exceed Amount”). Counsel may cease work upon delivery of notice to County and Commission upon reaching the Not-To-Exceed Amount, whether or not further legal services are required in connection with this Agreement; provided, however, that Counsel shall immediately resume such work if the County and Commission increase the Not-To-Exceed Amount through a written amendment to this Agreement signed by all parties.

2. The Agreement shall be amended to replace Section 3.1 in its entirety to state:

3.1 Term. The term of the Agreement (“Term”) shall be through June 30, 2025, unless extended by the Parties in writing through an amendment to this Agreement.
