IV. CHIEFS REPORT

- A. Fire Chiefs Report (Deputy Chief Ryan Silva on behalf of Chief Tony Mecham)
 - 1. Deputy Chief Silva provided the following information and updates:
 - A 12-month calendar was pushed out which will help with training for personnel.
 - Transitioned into winter staffing; went from 18 state station staff to 14 state station staff.
 - Zone Haven will be rolled out on May 1.

Director Jeff Collins provided the following information and updates:

- Ambulances total of 22.
- Full transition on September 30.
- Ag Pass total of 118 renewed, 12 new applications in the queue.
- Fire Station in Jacumba needs to be replaced. Baywa is donating land for the Fire Station.
- East Otay Mesa Fire Station 38 moved in. The area continues to develop.
- V. NEW BUSINESS
 - A. Updating the Ambulance Transportation Fees in the San Diego County Fire Protection District Ground Ambulance Service Area–Pending Board of Directors Action

On July 28, 2022, San Diego County Fire Protection District (SDCFPD) established ambulance transportation fees in anticipation of operating direct ambulance services in the community of Ramona starting August 1, 2022. On May 23, 2023, the Board of Directors authorized the Executive Director to enter into a contract with the County of San Diego to provide ambulance transportation services in the areas where the County has, or will have, that responsibility upon the expiration of existing contracts. This included in the area formerly known as the Unified Service Area. On September 30, 2023, the SDCFPD Ground Ambulance Service Area (ASA) became operational. The ASA now operates 22 ambulances in our rural communities through CAL FIRE and AMR.

It is anticipated the (ASA) will have a \$3M to \$5M deficit based upon the current fee schedule, minimum service levels and projected collections. County Fire staff worked with an outside

consultant in emergency medical services to evaluate several fee schedule options to reduce this gap. In addition, recent legislation provides an opportunity to generate additional revenue from private insurance and reduce the impact on patients and taxpayers. Assembly Bill 716 requires provider health insurance plans regulated by the State of California to pay the full cost of an ambulance transport if a local agency establishes a fee ordinance. However, Medi-Cal and Medicare, public health plans, have capitated rates and will only reimburse based upon what is in statute or regulations. County Fire is proposing:

B. Accept a Donation and Modify the Grounds on the Borrego Springs Fire Station for Firefighters to Live–Pending Board of Supervisors/Directors Action

On July 1, 2023, the Borrego Springs Fire Protection District dissolved and became part of the San Diego County Fire Protection District. There is one station to serve the community in Borrego but was built in the early 1960s and is inadequate for current operations. County Fire staff has been working with the community and Supervisor Desmond's Office to explore temporary improvements while funding can be identified for a replacement station.

County Fire has engaged with the Department of General Services to initiate a project that would add a temporary living trailer or update the current buildings. In addition, the Borrego Valley Endowment Fund is considering a donation to cover the costs for the trailer while the County pays for the site improvements.

NO ACTION required on this agenda item.

C. Authorize the Acceptance of a Donation from the Fire Safe Council of San Diego County–Pending Board of Supervisors Action

San Diego Gas and Electric (SDG&E) recently provided at \$60,000 donation to the Fire Safe Council of San Diego County (FSCSDC) for the purpose of applying long-term fire retardant (LTFR) along evacuation corridors in high fire risk areas throughout the County. FSCSDC has offered to pass the \$60,000 donation to County Fire to promote safety for our residents.

ON MOTION of Member Lyle, seconded by Member Sealey, the Advisory Board voted to receive an update on the SDG&E donation and vote in support of the proposed recommendation to receive

the funding for the purpose of applying long-term fire retardant along evacuation road (included for consideration in the Board Letter scheduled for the January 23, 2024 Board of Supervisors meeting).

D. Authority to Accept \$1.6M in Grant Funding from the Governor's Office of Planning and Research, Regional Resilient Grant Program for community education, community chipping and roadside vegetation management–Pending Board of Supervisors Action

In August 2023, County Fire jointly applied with San Diego Fire-Rescue and the Fire Safe Council of San Diego County to the CA Governor's Office of Planning and Research *Regional Resilience Grant Program.* A total of \$1,588,838 was requested to fund three main objectives: 1) provide equitable public education and community engagement, 2) assist residents with maintaining defensible space by offering free community chipping, and 3) reduce the chance of a roadside fire start and protect evacuation corridors for safe evacuation through roadside vegetation management.

On December 21, 2023, County Fire was notified that our application was successful. Through this grant, the following activities will occur over the next two years: working with Fire Safe Councils to update Community Wildfire Protection Plans, hosting Wildland Urban Interface and Last Chance Survival workshops, providing 24 free community chipping events throughout the County, and treating approximately 150 miles of evacuation routes with expanded roadside vegetation management. Because vulnerable populations bear an unequitable share of the risks and the consequences of wildfire, special attention will be given to ensure targeted service to individuals with disabilities or access and functional needs, limited English proficiency, geographically isolated individuals, households with low broadband subscription, seniors and older adults, and low-income individuals or families.

ON MOTION of Member Shanley, seconded by Member Kellogg, the Advisory Board voted to support County Fire in accepting these funds and to be applied as previously described.

FirstWatch Contract May 21, 2024

Description: San Diego County has been receiving near real time 911 emergency medical services (EMS) call center surveillance data from all four 911 dispatch centers in the County and have contracted with FirstWatch Solutions Inc. (FirstWatch) for data integration and analysis. Since 2009, FirstWatch has gathered, analyzed, and managed the 911 call data for the County of San Diego. To continue to effectively deliver these services for data management, historical access to data, and interoperability between other agencies also using FirstWatch. San Diego County Fire is requesting single source approval to procure a new contract with FirstWatch. The current contract with FirstWatch is set to expire on June 30th, 2024.

Recommendation: Support the procurement of a new contract with FirstWatch.

ZOLL and Stryker Sole Source May 21, 2024

Description: SDCFPD maintains fire apparatus, ambulances, and provides critical equipment to staff, ensuring all emergency responders have the necessary tools to deliver the highest level of fire and emergency services in the region. To effectively deliver these services, SDCFPD requires standardized equipment and gear. Emergency responders are trained in using the current cardiac and medical equipment. Two SDCFPD contracts that provide critical emergency medical services support in our suburban and rural communities are expiring in 2024 ZOLL Medical Corporation's (ZOLL) cardiac monitors and Stryker's patient gurneys and medical equipment. All SDCFPD ambulances and first responder engines have equipment from these providers onboard. SDCFPD is requesting single source approval to procure from: ZOLL (cardiac equipment, related accessories, repair and servicing of the equipment, warranty services, and software for operating the equipment) and Stryker (medical equipment, gurneys, related accessories, repair and servicing of the equipment, and warranty services).

Recommendation: Support the procurement of new contracts with ZOLL and Stryker.

Grant Acceptance California Climate Investment Wildfire Prevention Grants Program June 4, 2024

Description: County Fire has been awarded grant funding from the California Department of Forestry and Fire Protection's (CAL FIRE) California Climate Investments Wildfire Prevention Grants Program. The department will receive an award of \$946,858 which will be used to treat an additional 215 lane miles of roads with hazardous fuels reduction per year, through March 2026. County Fire is requesting the Board of Supervisors to adopt a resolution to accept funding under the California Climate Investment Wildfire Prevention Grant.

Recommendation: Support the acceptance and use of the California Climate Investments Wildfire Prevention Grant.

SDCFPD Annual Fire Mitigation Fee Program Participation Resolution & Capital Improvement Plan June 4, 2024

Description: To participate in the FMF Program, fire agencies must adopt a resolution on an annual basis authorizing participation in the FMF Program that states the percentage of the maximum fee ceiling for collection and adopt a plan for the future use of FMF revenue. The Fiscal Year 2024-25 Fire Mitigation Fee Program Fee Schedule for SDCFPD is listed below and includes the automatic cost escalator based on the annual Los Angeles Construction Cost Index (LACC Index) based on the previous 12-month period (October to October). The LACC Index increase for the FMF program for FY24-25 is 15.20%. The residential fee rate for FY24-25 will be collected at 75% of the determined rate.

The FMF will generate approximately \$2,000,000 in revenue in the next fiscal year. The use of mitigation fees will be used to support new development within the boundaries of the San Diego County Fire Protection District to include:

- 1. Save and/or utilize funding for fire station projects identified in the Capital Improvement Needs Assessment
 - a. Training Center
 - b. Station 80 expansion
- 2. Save and/or utilize funding for vehicles in accordance with the Department Fleet Plan
 - a. Additional Ladder Truck (Station 38)
 - b. Second Light and Air Vehicle

Recommendation: Support the participation in the FMF program and the Capital Improvement Plan for FMF revenue.

Annual Levies, Community Facilities Districts & Special Taxes June 26, 2024

Description: The County of San Diego Department of Public Works (DPW) and Department of Parks and Recreation (DPR) are putting forth the annual special tax board actions. Upon approval, the annual levies will be placed on the tax roll so that the property owners can continue to pay the levy through their property tax bills. County Fire receives special tax revenue from:

- Sand Diego County Fire Protection District
 - \circ 10 Zones within the FPD
- County Service Area (CSA)
 - CSA-17 San Dieguito Emergence Medical Services
- Community Facilities District (CFD)
 - o CFD 04-1 (Lake Morena, Jacumba, Jamul, and Lyons Valley Region)
 - CFD 09-1 (Otay Mesa Region)

Recommendation: Support the annual special tax board actions.



Grant Acceptance Cal OES FEMA August 27, 2024

Description: County Fire was awarded \$1.28 million through Cal OES's FEMA PDM 2024 Notice of Funding Opportunity. The intent of the grant funds will be used to harden/retrofit County Fire Stations. Funding will provide:

- Defensible space and hazard inspection of all 20 County owned fire stations
- Vegetation management & defensible space clearing around stations
- Station hardening & retrofit applications (fire resistant vents & windows)

County Fire will prioritize service based on hazard severity, structure vulnerability and anticipated impact on the community if facility were to be damaged or lost by wildfire. Depending on cost, not all facilities may be able to receive service, but all stations will receive hazard assessments by County Fire. The department will be meeting with a contractor supporting Cal OES Mitigation to discuss the terms of the grant.

Recommendation: Support the acceptance and use of Cal OES FEMA PDM 2024 grant funding.
